OTHERS PRESENT: Marinella Di Vita, Town Clerk & members from the public.

Presentation by Rob Gauchat from Solar Liberty about the future project on Fishman Road. Persons present during this presentation, Town Board of Town of Rockland, Town of Liberty Supervisor Frank DeMayo and his assistant Nick, and some members from the public.

Meeting was to brief everyone on the engineering and project management for the project and estimated cost that would need to be paid to get this project going with the CESIR study. Rob Gauchat shows both Towns Supervisors the grid chart of the varying dollar amounts, after 11 years of having the Solar Plant the turn around that money can be made after investing in the project. He explains that engineering, project management, employees, and construction as well as the 7 ft agricultural fence and the service road is all included. The only thing the Town's would be responsible for is the tree removal on the property to save money from the project. Estimated interconnection costs are estimated to come from NYSEG at about \$304,750.00. The Direct pay or (tax credit) \$541,000.00. The net cost after incentives comes 1,088,997.40. This does include prevailing wages but doesn't include 10K for CESIR costs or utility upgrades.

Frank DeMayo, Town of Liberty Supervisor - He's concerned and surprised that NYSEG wouldn't be willing to negotiate to lower spending costs because they are the ones in need of power, he and town of Rockland Supervisor, Robert Eggleton plan to have some communication to NYSEG constituents to negotiate better pricing for the project.

Bryan McPhillips, District 3 Legislature - asked how the process would work with disposal of material including steel and led, if there is any recycling that is including after the 35 year turn around? Rob Gauchat says it is in the works to get a system to recycle the material, but as soon as the material is officially recycled, the land becomes what it was previous to have a solar plant put on it, everything is removed pretty easily.

Sheila Shultz, member of the public - There was some issue with infrastructure availability that was questionable at the time, is that still a problem? She also asked if there is a space saver so we are set in stone? Rob Gauchat says that this property had went through the preliminary study twice, the hosting capacity maps show how much solar is on there and how much is on Q to get connected, that is the only view we have. There was a 5 Megawatt array that was not in the Town of Rockland's favor so we waited. That 5 megawatt array fell out, we don't know why but when they bailed it opened up the capacity of the system so that allowed Town of Rockland to get back in for a chance. Gauchat says by April 29<sup>th</sup> we have to pay \$10,000.00 to save the spot for the Town of Rockland in the Q.

Frank DeMayo, Town of Liberty Supervisor - After the Solar property starts to generate income for the Town's, I think it's extremely important to put aside some income for decommissioning so the future generation doesn't have to haul our weight from this project. He also asked Rob Gauchat if there is a way he can present this to the Town Board in the Town of Liberty since they are just getting caught up on everything.

- NYSEG is providing bill credit for all customers under miscellaneous credits. Credit customers will be \$9.52 and cash customers will be refunded a credit of \$15.16
- Sullivan County Shields, not-for-profit law enforcement organization, is looking for a Board of Directors Secretary. If interested please contact Peter Chiavaro at 845-701-2704. One does not need to be law enforcement to join. This organization supports Sullivan County Law Enforcement officers and their families who have lost their lives or were injured in the line of duty. They also honor active officers and grant scholarships to those who pursue law enforcement (2-\$500.00 scholarships have been approved already for 2024) 100% of all funds go to the cause of this organization
- Sullivan County Treasurer's Office and the Legislature announce that the repurchase period for tax-foreclosed property has begun. One of the last opportunities for homeowners to regain ownership. Through June 30<sup>th</sup> taxpayers need only to pay all of the delinquent property taxes up to and including 2024. No penalties or fees will be added on. After June 30<sup>th</sup>, the County will turn over the property to the tax auction company and the amount to repurchase property will be significantly higher. The last day to repurchase is August 23<sup>rd</sup>, 2024
