APPROVAL OF MINUTES

A Motion was made by Mrs. Routledge seconded by Mr. McRell to approve the minutes from the September 1st, 2024 board meeting

PUBLIC HEARING 7 PM – Request for waiver from Moratorium

Supervisor Eggleton begins public hearing with a small explanation of the project and why they are requesting the waiver from the Moratorium, to proceed with Planning and Zoning boards

John Furst from Catania, Mahon and Rider PLLC Attorneys at Law presented board members and the public with presentation of the Keiser Redevelopment Project that Livingston Legacy Holdings LLC. Other members of this project present were owner of Livingston Legacy Holdings LLC, Bon Yagi, project manager, Michael Tucker, and Engineer for the project, Zach Szabo. Seeking a waiver from the new Moratorium to be able to proceed to planning and zoning boards. During this presentation, it is explained out this project would benefit the environmental quality and have a lasting positive impact on the community. The structures are all pre-existing so nothing would need to be built but to be revitalized.

John And Lauren Aichinger, neighbors to the Keiser Redevelopment Project, explained the benefits of this project and described that they are currently working with NY Forward Grant to build some apartment buildings near the proposed project.

Vanessa Mcphillips from the Sullivan County Partnership also explained some more benefits that Livingston Legacy Holdings LLC's project would provide to the community. She explained how the project is very in line with what the downtown has grown to be like, and it would only benefit the community.

A motion was then made by Mr. McRell and seconded by Mrs. Routledge to close the public hearing

RESOLUTION #130 Livingston Legacy LLC Waiver to Moratorium

A motion was made by Mrs. Routledge and seconded by Mr. McRell with all in favor to allow the Livingston Legacy Holdings LLC to move forward with their mixed use tourist destination through the planning and zoning process which is currently outlined in our Moratorium

PUBLIC HEARING 7:10 PM – Use of Building Reserve Funds For Emergency Repairs

Supervisor Eggleton starts public hearing with discussion about some repairs that need to be done on some of the Town Properties. He explains how the Town of Rockland Highway Salt Shed repairs have been out for bid for quite some time and we have finally got a bid for \$73,460.00 and the Air conditioning at the Town Hall has been failing all summer long so the town has an estimate on mini split systems for the Town Hall (2 upstairs and 2 downstairs). These also supply heat to the building which will cut costs on heating oil as well. That estimate came in at about \$17,800.00. Supervisor Eggleton explained also how some repairs like basic maintenance needs to be done at the Golf Course. The Requested amount to be taken from the Building Reserve Funds would be up to \$100,000.00.

Public Comment - John Hendrix asked if these would replace current heating source
